



HOUSE RULES

Ariya's House is based upon all the following rules.

Residents are encouraged to work a focused program of recovery, as applicable, this includes:

- Staying clean and living a sober way of life.
- Attending Recovery meetings
- Working with sponsor or mentor
- Participating in a support group
- Working the spiritual 12 steps of AA (or program equivalent and approved by WoH).

LEVEL II HOUSE RULES

1. The use of alcohol, drugs or any mood-altering substance (including the use of supplements, steroids, energy drinks and mouth wash containing alcohol) is strictly prohibited. All Residents are subject to random toxicology testing and a property search at any time.
2. NO Redbull, Redline, or other energy drinks. This includes drinks such as "Starbucks Energy". Most energy drinks contain 0.5% alcohol (less than required to be put on label). If the can has the word "Energy" do not get it.
3. The use and/or possession, including paraphernalia, will result in the immediate termination of residency.
4. All residents will need to attend 5 meetings per week, at a minimum, depending on IOP, work and school schedule. The number of meetings per week will be determined on an individual basis, as appropriate.
5. All medications must be kept in provided lock box.
6. No sharing of medications. Random pill counts will occur.
7. Gambling in any form is not permitted.
8. No Smoking in the house, only designated areas outside.
9. No open flames in the house at any time. This includes, but not limited to, candles and incense. Also excluded are individual space heaters.
10. Physical confrontations, verbal threats or physical threats will not be tolerated.
11. Weapons are prohibited on the property.
12. Any members of the opposite sex in your bedroom for any reason, at any time, will result in the immediate termination of your residents.
13. Romantic relationships are not allowed between residents.
14. All activities should be quieted by eleven in respect for other residents. Hours should be reasonable and conducive for recovery.
15. Residents are permitted to stay overnight after obtaining approval and lived on premises for over 30 days, up to 24-hour prior approval.
16. Each resident is responsible for their own personal cleanliness and laundry, as well as the general cleanliness of the house as assigned in the weekly community meeting.
17. All residents should be actively seeking employment, attending school or volunteering within two weeks of admittance into Program.
18. All residents will attend weekly house community meetings.
19. Guests are only permitted to pick up or drop off resident as pre-approved with housing coordinator. Visits will take place off site.
20. Curfew: 9:00 p.m. 7 days a week for Phase I.
21. Each resident will be on 30- or 60-day probation period. After completion of a 30-day assessment, the probation period will be reviewed, case by case basis.
22. Weekly house meeting is mandatory.

The Ariya's House reserves the right to remove anyone from the house for non-compliance with the rules or polices of the house.
